Commissioner Quinn made a motion to allocate funds from line 56800 –Road Fund –Maint- in the amount of \$1,799 to pay David Self for painting and general repair of the front fence. The motion was seconded by Mayor Salmon and was passed unanimously.

Commissioner Quinn made a motion to allocate funds from line 54200 –Parks –Social- in the amount of \$740 to pay for the Fall Festival. The motion was seconded by Mayor Salmon and was passed unanimously.
